# Introduction

For the last few years, the Commission has strengthened its efforts to incorporate the questions related to migration and asylum in its political dialogue with third countries, propose comprehensive approaches to migration and mainstream these questions in its development cooperation strategies. As regards cooperation, and in parallel to the contribution of the geographical instruments, the Commission has been funding actions also through thematic instruments, such as the "Aeneas" programme (2004-2006), which followed the preparatory actions financed from the budget heading B7-667 between 2001 and 2003. The aim of these thematic instruments isto assist third countries in their efforts to better manage migratory flows. Initially created to cover the period 2004-2008, 'Aeneas' was shortened to three years (2004-2006), during which about € 120 million of migration related projects have been financed. Within the framework of the Financial Perspectives 2007-2013, 'Aeneas' has been replaced by the Thematic Programme on cooperation with third countries in the areas of migration and asylum.

The general objectives of this Thematic Programme and its areas of activity are laid down in Article 16 of Regulation (EC) No 1905/2006 establishing a financing instrument for development cooperation (DCI), and specifically aim to support third countries in their efforts to ensure better management of migratory flows in all their dimensions. While the subject of the Thematic Programme is primarily migration to the Community, it also takes into account the relevant south/south migratory flows. At the thematic level, the programme covers major fields of action, which correspond to the main aspects of the migratory phenomenon, namely:

(a) fostering the links between migration and development, especially by encouraging the contribution of diasporas to the development of their country of origin and increasing the benefits of migrants' return; mitigating brain drain and promoting the circular movement of skilled migrants; facilitating financial transfers of migrants to their country of origin; supporting voluntary return and reintegration of migrants and building capacities for migration management; fostering capacity building efforts to help countries in the formulation of prodevelopment migration policies and in their capacity to jointly manage migration flows;

(b) promoting well-managed labour migration, in particular by informing about legal migration and conditions of entry in and stay on the territory of the Member States of the Community; providing information on labour migration opportunities and needs in Member States and on qualifications of third country candidates for migration; supporting pre-departure training for candidates for legal migration; and encouraging the definition and implementation of legislative frameworks for migrant workers in third countries;

(c) fighting illegal immigration and facilitating the readmission of illegal immigrants, including between third countries, and in particular, fighting smuggling and trafficking in human beings; discouraging illegal immigration and raising awareness of the risks related to it; improving capacities in the areas of

border, visa and passport management, including the security of documents and the introduction of biometric data, and detection of forged documents; implementing effectively readmission agreements concluded with the Community and obligations arising out of international agreements; and assisting third countries in the management of illegal immigration and in the coordination of their policies;

(d) protecting migrants, including the most vulnerable such as women and children against exploitation and exclusion through measures such as developing third countries' legislation in the field of migration; supporting integration and non-discrimination as well as measures to protect migrants from racism and xenophobia; preventing and fighting the smuggling and trafficking in human beings, and any form of slavery;

(e) promoting asylum and international protection, including through regional protection programmes, in particular in strengthening institutional capacities; supporting the registration of asylum applicants and refugees; promoting international standards and instruments on the protection of refugees; supporting the improvement of reception conditions and local integration, and working towards lasting solutions.

This publication presents the first collection of projects financed by the Thematic Programme in 2007 and 2008. Fifty four projects were selected through the Call for Proposals 2007-2008 and nine additional projects were financed through direct awards<sup>1</sup>. An overview of all projects financed during this period is presented, followed by a summary description of each project. The duration of projects and some implementation details (such as activities, results, and implementing partners) may vary or change during their evolution.

A Mid-term Review of the Thematic Programme is currently being carried out by a team of experts external to the European Commission and should be available in the course of 2010.

#### Objectifs

- Sur le champ des migrations des travailleurs:
  - ⇒ Renforcer les capacités des Ministères du Travail, Services Publics de l'Emploi et autres services nationaux, à gérer la migration des travailleurs en articulation avec les politiques de l'emploi et à fournir une information aux migrants potentiels sur les canaux pour la migration légale, sur les conditions d'entrées sur les marchés étrangers du travail et sur les risques liés à l'immigration illégale.

#### Activités

#### Objectifs

Promouvoir une démarche de prévention de la migration illégale de mineurs.

L'intervention se déroulera en 3 phases principales :

- Une phase de démarrage (2 mois) visant notamment à identifier les experts, élaborer les termes de référence pour mener l'analyse et la réflexion sur le phénomène.
- Une phase opérationnelle (20 mois) qui verra la réalisation effective d'une recherche transnationale et sa

- To cooperate with Libyan authorities to assess and to improve their overall capacity to address
  irregular migration at country level, including through improving their system of prevention and
  management of this phenomenon.
- To cooperate with Libyan authorities to improve their capacity to prevent and intercept irregular migration flows along Libya's southern borders and along the roads and tracks leading from the southern regions towards the Mediterranean coast.
- To cooperate with Libyan authorities to improve their capacity to investigate and prosecute smuggling of migrants and trafficking in human beings networks.
- To cooperate with Libyan authorities to improve their capacity to efficiently deal with apprehended irregular migrants in accordance with the best international standards and, in particular in providing assistance and protection to migrants in distress, in particular women, children and ill people.
- To cooperate with Libyan authorities to improve their capacity to efficiently manage apprehended irregular migrants in accordance with the best international standards.

# Activities

- An on-the-spot joint technical assessment will be carried out by the Technical Assessment Teams (TATs).
- Based on the findings of the joint technical assessment the Steering Committee will work out the Sahara-Med operational concept to be intended as an action plan aiming at establishing measures, methods and timing to meet the identified priorities.
- A plan for improving the system of collecting and analysing statistics and information on irregular migration will be carried out.
- Training will be performed for trainers, senior officers and staff on different subjects.
- Two study visits respectively to reception and detention centres for migrants and to the "risk analysis units" and "investigation agencies" in Italy or eventually in other EU Member States, will be carried out.
- The Joint Advisory Teams (JATs), coordinated by the Steering Committee, will assist the Libyan authorities in better organising the services in charge of border control and management of irregular migration in the southern regions and in the coastal areas, as well as of patrolling along roads and tracks in the desert leading from the southern regions of the country towards the Mediterranean coast.
- The Libyan authorities will be assisted to put in place an assisted system aimed at facilitating the voluntary return (AVR) mechanisms for irregular migrants.
- The Libyan authorities will be assisted to put into place a system aimed at facilitating "durable solution" for irregular migrants in need of international protection.
- Equipment and technical means will be supplied in order to enhance the operational capability of the Libyan competent authorities and to improve the accommodation conditions of irregular migrants at identified reception/detention centres in Libya.
- A multilateral high level technical meeting between representatives from the relevant authorities of Libya and from the neighbouring countries as well as a one-week training workshop on the basic tools of trans-border cooperation will be organized to improve the regional practical cooperation.

• A final conference will be held to evaluate and disseminate information on the project outcomes, as well as to discuss how an efficient model of Euro-African cooperation is supposed to be.

- Capacity of the competent Libyan national services to carry out risk and threat assessments improved;
- Capacity of surveillance along the borders and along the main routes leading from the border crossing points towards the internal parts of the country and the coastal areas enhanced;
- Capacity of movement for the Libyan law enforcement agencies, in view of facilitating detection of border violations, but also for the scope of search and rescue operations both in the desert and at sea, enhanced;
- Capacity to identify intercepted irregular migrants enhanced;
- Capacity to store and transmit data on the identity of the intercepted irregular migrants enhanced;
- Capacity to carry out targeted investigations to identify smugglers and traffickers improved;
- Assistance to the migrants stranded in the desert and/or detected during the controls improved;
- Special units trained/able to gather intelligence information by debriefing the illegal migrants detected;
- Specific procedures for identification and management of vulnerable persons and/or asylum seekers mainstreamed and applied;
- Technical equipment provided to improve the operational capacity of the relevant Libyan agencies in charge of border and migration management, search and rescue operations, investigation;
- Cooperation/coordination among Libyan national services involved in the management of irregular migration enhanced;
- A contact network between the Libyan authorities and the pertinent authorities of the neighbouring countries established to improve the trans-border cooperation;
- Trainers, senior officers and staff (dealing with patrolling, search and rescue operation at sea and in the desert, border and migration management, managing of centres for illegal migrants, detecting and processing vulnerable migrants and asylum seekers, enforcing return decisions, etc.) trained.
- Police officers from Libya and from the neighbouring countries trained on the use of transborder cooperation tools;
- Staff in charge of using and maintaining the technical devices and equipment (provided under the action) trained;
- Mechanisms and modalities identified to link the illegal migration management procedures at the southern borders with the sea border control and surveillance system that Libyan authorities have been setting up with the support and the technical assistance of the Italian Ministry of Interior;
- Improved capacity of the Libyan authorities to treat irregular migrants intercepted in the southern regions and in the coastal or desert areas of the country improved in accordance with the humanitarian international standards;
- Priority needs and basic requirements in centres of southern Libya for migrants reception and accommodation according to international humanitarian standards, identified;
