## T. MEMBER STATE INSPECTIONS

Member States' obligation to ensure the effective control, inspection and enforcement of the CFP:

- 1. Geographical scope of Member States' responsibility:
- On their territory, in waters subject to their sovereignty and jurisdiction: on all vessels/persons/businesses;
- Outside Community waters: fishing activities of vessels flying their flag and of their nationals.



# MEMBER STATE INSPECTIONS

#### 2. Inspection and enforcement system:

- Allocating appropriate financial and human resources;
- setting up administrative and technical structure;





## MEMBER STATE INSPECTIONS

- Adopting properly documented, effective, dissuasive and proportionate measures, including:
  - a) Regular spot checks and inspections;
  - b) Sighting of vessels;
  - c) Investigation, legal pursuit of infringements and sanctions (administrative and criminal follow-up);
  - d) Preventive measures (immediate measures in case of in flagrante delicto);
  - e) Measures to prevent the involvement of their nationals in fisheries activities that do not respect the applicable conservation and management measures;
  - f) Cross-checks and verification of data (validation systems).

#### Characteristics of Commission inspections:

- Inspections carried out on:
  - ☐ Fishing vessels
  - Premises of businesses
  - Other bodies related to CFP
  - ☐ (Public premises and places)
- Commission inspectors have access to all information and documents needed to exercise their responsibility
- Member States have to cooperate with the Commission and afford all assistance needed to fulfil their tasks
