The EU Fertilisers Directives were transposed by the Ministry of Agriculture and Rural Affairs (MARA).

There are two transposing Regulations came into force on 27 October 2002 and repealed the corresponding mandatory national standards.

The Regulation on Chemical Fertilisers Used in Agriculture transposed the following Directives,

- 76/116/EC on primary fertilisers,
- 80/876/EC on ammonium nitrate fertilisers of high nitrogen content,
- 88/183/EC on 76/116/EC amendment on fluid fertilisers,
- 89/284/EC on 76/116/EC amendment on Ca, Mg, Na and S content of fertilisers, and
- 89/530/EC on 76/116/EC amendment on trace elements in fertilisers, and

was published in the Official Gazette dated 27 March 2002.

This Regulation was amended on 7 November 2002 in accordance with the 98/003/EC and 96/028/EC (76/116/EC amendments).

On the other hand, the Regulation on Chemical Fertiliser Inspection transposed the following Directives,

- 77/535/EC on sampling and analysis methods,
- 79/138/EC 77/535/EC amendment,
- 87/566/EC amendment.
- 87/094/EC on characteristics of ammonium nitrate fertilisers of high nitrogen content, their limitations, and their resistance to detonation, and

was published in the Official Gazette dated 25 April 2002.

This Regulation was amended on 26 October 2002 according to 89/519/EC on analysis methods of secondary elements, and 98/1/EC on analysis methods of microelements.

After the publication of the Regulation 2003/2003/EC, the Regulation on Chemical Fertilisers Used in Agriculture was amended on 18 March 2004 and put into force on 15 April 2004.

In accordance with Articles 15 and 16 of Chemical Fertiliser Inspection Regulation, the reference and analysis laboratories which will be used during market inspections of fertilisers with "EC FERTILISER" indication should have sufficient equipment and personnel for implementing analysis methods referred to in the Annexes of the Regulation.

The names of these laboratories are published in the Official Gazette at the beginning of each year. The laboratories were communicated to the European Commission in August 2005.

The inspections are carried out as the inspection of production and market places, where complaints are also taken into account for performing the market surveillance.

The market surveillance for chemical fertilisers is based on Regulations on inspection and the Circulars according to these Regulations.

250 chemical fertiliser inspectors, who work in 81 Provincial Directorates of MARA, are trained about chemical fertiliser inspections to carry out market surveillance.

It will be financed as a sub-component of the "Plant Production and Development Project" that has a annual share from the budget, and planned to be financed by this way furthermore.

The "Law No. 4703 on the Preparation and Implementation of Technical Legislation on Products"; Regulations based on the Law No. 4703; the "Chemical Fertiliser Inspection Regulations" and Circulars based on these Regulations, are the legal basis for implementation in this area.

In 2004, throughout the country, 5,439 premises were visited in the scope of production, purchase, storage conditions and product labelling control. During these visits, 1,041 samples were taken and 127 of them were found non-compliant. As a result, 741 tonnes of chemical fertilisers were withdrawn from the market.

In the year of 2005, 4,039 premises were visited and 634 samples were taken out of which 51 was found non-compliant. As a result, 389 tonnes of chemical fertilisers were withdrawn from the market.
