Implementation will be ensured by responsible Central Department, 27 District Forestry Authorities and enterprises under them as well as experts and inspectors of central department and District Directorate of forestry through training, guiding, monitoring and controlling of conformity of standards.

If CEN Standards are applied, additional help will be provided by experts of Turkish Standards Institution through controlling conformity of standards

According to current implementation (not harmonised), Market surveillance is carried out by related central body of General Directorate of Forestry on country level and by related section of district directorates on regional level.

According to current implementation (not harmonised), number of technical personnel working in responsible central body and related section of district directorates is about 100. Besides personnel for market surveillance, there are about 1,200 stuff working in field to implement classification and standardization. These personnel will be available for implementation of the Directive.

Budget of General Directorate of Forestry is providing necessary financial source at current implementation. This financial source will be available and if necessary can be expanded for the implementation of harmonisation of the Directive

More than 99% of forest is belong to state and General Directorate of Forestry (GDF) is responsible agency of government for sustainable management of states forests. Besides, the management of private forests is under the authorisation of GDF.

In other word, the classification facility of nearly all round wood production of country is achieved by enterprises working under the GDF. Therefore all authoritative and administrative power of GDF and other (financial, institutional and personnel) possibilities of GDF will be available for enforcing compliance with the Directive

The implementation of harmonisation and compliance with the Directive will be voluntary for private forest owners

Administrative measures include disciplinal penalties, warning, etc.

The power of authority and rights came from related Article of Law No. 6831 on Forestry.

Administrative and disciplinal penalties are applicable at current implementation. Besides, other penalties such as warning and cancelling of licence may be applicable depending on having conformity licence and using right of mark of related standards.

Dimensional and qualitative classifications are made according to criterion similar to the criterion expressed in the annex of Directive 31968L0089. These classifications mainly are based on Turkish Standards on round wood. Measurement is by volume (cubic metre and stere) and metric system is used for measurement.

Further evolution will be determined at the stage of harmonisation of the Directive.
