FOREWORD

Strengthening the civil society is one of the priority areas that Türkiye focuses on with the financial aid received in the process of accession to the European Union (EU). In the second period of the European Union Instrument for Pre-Accession Assistance (IPA), covering the years 2014-2020, "Civil Society" has been defined as a sub-sector under the Democracy and Governance Sector. The Republic of Türkiye Ministry of Foreign Affairs Directorate for EU Affairs was authorized to create a strategy for the use of the budget allocated to support the civil society sector in Türkiye, as well as creating programmes' project identification, and the monitoring of projects and programmes.

The Directorate for EU Affairs, which attaches importance to the development of civil society in Türkiye, has gathered the support given to the civil society field and its actors under the umbrella of the "Civil Society Sector" through a sectoral and systematic perspective. Under this programme which brings together public institutions and civil society organizations (CSOs), many projects have been implemented in different fields, lives in every corner of Türkiye have been touched, the capacities of CSOs have been improved, and a basis for working together, producing together, and living together have been laid.

The Civil Society Support Programme First Period (CSSP I), implemented between 2018-2021 under the umbrella of the Civil Society Sector, aimed at more effective participation of CSOs in decision-making processes and the improvement of public-civil society relations at the local and national levels. Also, the management, advocacy, and communication skills of CSOs were improved.

The Civil Society Support Programme Second Period (CSSP II) was implemented as a continuation of the first period and was carried out between 2019 and 2021. With a grant support of 3.7 million Euros for twenty nine projects carried out during the period, it was intended to develop a stronger civil dialogue between CSOs and public institutions, and to enhance the participation and capacities of CSOs. Within the framework of the programme, projects on different topics such as health, agriculture, education, environment, food, and media for different target groups such as women, children, youth, and disadvantaged groups were implemented in Ankara, Denizli, Diyarbakır, Erzurum, Hatay, İstanbul, İzmir, Mardin, Uşak, Van, and Zonguldak.

We are happy to share with you the stories of the projects carried out in the Second Period of the Civil Society Support Programme in this project compendium. We sincerely congratulate all CSO representatives who contributed to the projects and hope that the projects they have completed will inspire other CSOs.

A. THE CIVIL SOCIETY SUPPORT PROGRAMME FOR A STRONG CIVIL SOCIETY, FROM PAST TO PRESENT

Civil society has become an important actor in Türkiye's accession negotiations with the European Union (EU) due to the Negotiation Framework Document and the Copenhagen political criteria. It is widely recognized that a healthy functioning democracy, the achievement of EU standards, and the establishment of consistent relations between Turkish and EU societies are possible with a strong civil society.

Civil society support provided on various themes under different priority areas until 2014, was grouped under the umbrella of the "Civil Society Sector" in the Second Period of the Instrument for Pre-Accession Assistance (IPA II), which covers the years 2014-2020. As the leading institution of the Civil Society Sector, the Republic of Türkiye Ministry of Foreign Affairs Directorate for EU Affairs was responsible for programme development, implementation, and monitoring.

The Civil Society Sector supports four priority areas:

- Improvement of the legal framework for CSOs
- Supporting public-civil society cooperation
- Strengthening the capacities of CSOs
- Developing the civil society dialogue between Türkiye and the EU

I. THE FIRST PERIOD OF THE CIVIL SOCIETY SUPPORT PROGRAMME (CSSP I)

The first phase of the Civil Society Support Programme (CSSP I) implemented within the scope of the Civil Society Sector aimed to ensure more effective participation of CSOs in decision-making processes, strengthening public sector and civil society relations at local and national levels, and supporting the management, advocacy, and communication capabilities of CSOs.

The first period of the Civil Society Support Programme consisted of the following components:

- Grant Scheme for Grassroots Civil Society Organizations (GRS)
- CSO Partnerships and Networks on Strengthening Cooperation Between Public Sector and CSOs Grant Scheme (CSPN)

Through the CSO Partnerships and Networks on Strengthening Cooperation Between Public Sector and CSOs Grant Scheme (CSPN), it was intended to strengthen the cooperation between public institutions and CSOs and to improve the capacities of CSOs by supporting the partnerships and networks to be developed by financially and administratively powerful CSOs. Within the scope of the programme, approximately 4.2 million Euros of grant support was provided to ten CSOs.

Through the Grant Scheme for Grassroots Civil Society Organizations (GRS), with a grant budget of approximately 2.1 million Euros, it was aimed to strengthen the institutional capacities of CSOs, to support their lobbying and advocacy activities, and to improve their communication skills. The programme which included 38 projects in 15 different provinces of Türkiye, played an important role in spreading EU funds to Anatolia.

II. THE SECOND PERIOD OF THE CIVIL SOCIETY SUPPORT PROGRAMME (CSSP II)

As a continuation of the first phase, the second phase of the Civil Society Support Programme, put into practice in 2019, aimed at enhancing the capacities of CSOs for a stronger civil society dialogue, participation, and elevated reputation, with a grant budget of 3,8 million Euros.


In the second period, it was primarily intended to

- ensure the administrative and financial sustainability of CSOs,
- enhance their communication and advocacy skills,
- improve their participation in decision-making processes at local, national and international levels,
- strengthen their transparency and accountability, and increase the role of the CSOs in the dissemination of active citizenship.

The programme reached CSOs operating in a wide range of areas such as health, agriculture, education, the environment, food, and media for different target groups such as women, children, youth, and disadvantaged groups.

Within the scope of the second period of the Civil Society Support Programme;

- 31 projects from 12 provinces of Türkiye were entitled to receive grants, 29 projects were successfully implemented,
- 18 projects set out with a co-beneficiary, although there was no partnership condition,
- co-beneficiaries from the Netherlands, Germany, Italy, and Austria also participated in the programme with their Turkish partners.

III. THE CIVIL SOCIETY SUPPORT PROGRAMME-II TECHNICAL **ASSISTANCE PROJECT**

Technical Assistance for Implementation of Civil Society Dialogue and Civil Society Support **Programmes Project Kick-off Meeting**

February 6th, 2019

Technical Assistance for Implementation of Civil Society Dialogue and Civil Society Support Programmes Project kick-off meeting was held at the Directorate for EU Affairs. At the meeting, the activities of the technical assistance project for the implementation of the support to be provided to civil society in the new period and the team that would take part in the activities were introduced.

Civil Society Dialogue-V and the Civil Society Support Programme-II Opening Ceremony April 10th, 2019

The opening event of the Civil Society Dialogue-V and Civil Society Support -II Programmes, which included 69 projects, took place in Ankara with the participation of a great number of quests.

Grant Implementation Training Programmes

April 11th- 12th, 2019

The Civil Society Dialogue-V and the Civil Society Support-II Programmes Grant Implementation Training programmes were held in 5 simultaneous sessions in Ankara with 150 CSO representatives participating. Participants obtained information about the implementation period through meetings with the management units of the project.

Diplohack, Ankara

July 4th- 5th, 2019

Diplohack was held in Ankara with the theme of "Civil Society Dialogue Between Türkiye and the EU". Approximately fifty participants from different provinces in Türkiye, developed creative ideas and shared their experiences to strengthen the civil society dialogue between Türkiye and the EU.

Brand Workshop

July 11th, 2019

In the Brand Workshop, which was held to strengthen perception and communication activities within the scope of the Civil Society Dialogue-V and the Civil Society Support -II Programmes, the topics of "the power of the brand concept" and "brand positioning" were emphasized. Relevant experts who participated in the group activities at the Brand Workshop exchanged ideas on strengthening the promotion of the Civil Society Dialogue and Civil Society Support Programmes.

Communication and Visibility Training

July 30th, 2019

Civil Society Dialogue-V and Civil Society Support-II Programmes Communication and Visibility Training was held with the participation of a great number of civil society representatives. The training focused on the concept of communication and its components, along with informative presentations as well as workshops.

Civil Society Support Programme-III Briefing Meetings

July 29th- August 2nd, 2019

The first briefing meeting of the Civil Society Support Programme – III was was held in Ankara with the participation of Deputy Minister of Foreign Affairs and Director for EU Affairs, Ambassador Faruk Kaymakcı, on 29 July 2019. Subsequent meetings were held in Antalya on July 30th, 2019, in Bursa on July 31st, 2019, in Istanbul and Izmir on August 1st, 2019, and in Trabzon on August 2nd, 2019.

First Steering Committee Meeting

September 2nd, 2019

The first Steering Committee Meeting of the "Technical Assistance for Implementation of Civil Society Dialogue and Civil Society Support Programmes" Project was held on September 2nd, 2019, under the coordination of the Directorate for EU Affairs. At the meeting held under the chairmanship of the Head of the Department of Project Implementation, A. Hakan Atik, activities were evaluated, and the work planned for the next period was discussed.

Digital Tools Training

September 4th, 2019

Digital Tools Training, designed for the staff of the Directorate for EU Affairs, was held in Ankara. The training programme focused on the use of applications that facilitate business and daily life. During the two-day training period, a total of five modules were completed and case studies were conducted at the end of the day. The titles of the modules were: "Digital Tools for Collaborative Work", "Interactive Presentation and Feedback Tools- What is Multimedia Design Theory?", "Visualization of Information, and Data and Data Analysis Tools", "Social Media Usage and Design Elements", and "Digital Content Development-Analysis with Social Media Tools".

Civil Society Gathering: Social Entrepreneurship Support Meeting

September 14th, 2019

The "Civil Society Gathering" meetings, coordinated by the Directorate for EU Affairs, brought relevant parties together on September 14th, 2019, by hosting the Social Entrepreneurship Support event. The opening of the meeting was carried out by A. Hakan Atik, Head of the Department of Project Implementation, Directorate for EU Affairs, and Ahmet Karan, Social Policy and Employment Sector

Manager of the Delegation of the European Union to Türkiye. Nejat Doğan, a social entrepreneurship expert, was the moderator. Civil society organisations working in the field of social entrepreneurship, related departments of universities, and participants consisting of academics and experts exchanged views on the subject at the meeting held online.

Civil Society Dialogue-VI Programme Briefing Meetings

October 4th- 21st, 2019

Civil Society Dialogue-VI Programme Briefing Meetings were held in Istanbul on 4 October 2019, in Ankara on 7 October 2019, in Ordu on 9 October 2019, in Brussels on 10 October 2019, in Eskişehir and Mersin on 11 October 2019, in Malatya on 15 October 2019, in Izmir and Antalya on 18 October 2019, and in Edirne on 21 October 2019. Approximately 1200 civil society representatives participated in the meetings.

Advanced Presentation Techniques Training

December 2nd, 2019

On the first day of the Advanced Presentation Techniques Training held in Ankara for the staff of the Directorate for EU Affairs, topics such as time management, the miracle of motivation, persuasion communication, and body language tips were discussed. On the second day, the participants were informed on the Microsoft Office PowerPoint Program (Advanced Level), Microsoft Sway Application, and Prezi Application.

Final Report Preparation Training

March 2nd-4th, 2020

While detailed information on "technical reporting" and "financial reporting" was shared on the first and second days of the Civil Society Dialogue-V and the Civil Society Support -II Grant Programmes Final Report Preparation Training sessions, in which 70 different civil society organisations participated, the "Communication Strategy" of the Directorate for EU Affairs was emphasized on the third day.

Online Social Media Management and Digital Event Management Training

May 6th-8th, 2020

Digital applications that facilitate business and daily life were shared during the three-day Social Media Management and Digital Event Management Training course designed for the staff of the Directorate for EU Affairs. In the online training course "Tools for Webinars and Other Online Meetings", "Social Media Management" and "Social Media and Technology Tools" were discussed.

July 2nd, 2020

The "Join Us!" briefing meeting was held by the Directorate for EU Affairs to contribute to the planning of civil society support projects. The participants of the online briefing meeting had the opportunity to ask questions and express their opinions to the EU experts who provided information on the planned EU support for the upcoming period. The opening speech of the meeting was delivered by Bülent Özcan, Director General for Financial Cooperation and Project Implementationat the Directorate for EU Affairs. A. Hakan Atik, Head of Department of Project Implementation, and Mustafa Murat Özçelebi, EU Affairs Expert at the Directorate for EU Affairs, provided information on civil society projects and the IPA III Period within the scope of "Pre-Accession Financial Assistance". Independent expert, Ayça Bulut Bican, gave a briefing on the consultation process.

Second Meeting of the Steering Committee

December 22nd, 2020

The second Management Meeting of the "Technical Assistance for Implementation of Civil Society Dialogue and Civil Society Support Programmes" Project was held online. Technical assistance activities provided for the grant project and related programmes were evaluated. The activities to be carried out in 2021 were also discussed during the meeting.

Highlights from the Project

- A "CSO Capacity Evaluation Survey" was conducted for the CSOs in Afyonkarahisar, Izmir, Denizli, and Muğla, and the results were published as a report.
- Based on the survey report's results, capacity-building training was held for the CSOs in Afyonkarahisar, Izmir, Denizli, and Muğla.
- Dialogue Meetings were held.
- A "Communication and Consultancy Office" was opened in Ankara.
- A study visit to EU-related institutions in Ankara with the participation of 20 CSO representatives from the Aegean Region was realised.
- A workshop on public-CSO cooperation was held in the communication and consultancy office in Ankara.
- Manuals for strengthening the organizational capacities of CSOs were published.
- The closing meeting of the project was held.



We designed our project, which lasted for 15 months, to improve the administrative and financial sustainability of civil society organizations in the Aegean Region, to support active citizenship, and to ensure the participation of civil society organizations in decision-making processes at local and national levels. Within this scope, a situation assessment with preliminary survey studies in İzmir, Denizli, Muğla, and Afyonkarahisar was carried out. Based on the survey results, we provided "strategic planning" and "project cycle management" training to civil society organizations in these provinces to ensure administrative and financial sustainability. Additionally, we opened a communication and consultancy office in Ankara within the scope of the project. We held a workshop, and a video conference, and conducted study visits to support the participation of civil society organizations in the decision-making process. 


Highlights from the Project

We established a platform as a result of the 4 workshops we organized in Van with CSOs from all over Türkiye. On this platform, we carried out studies to ensure institutional capacity, advocacy, lobbying activities, disability rights, and cooperation so as to become stronger together. Thanks to the workshops, CSOs were informed about ways to ensure the rights of deaf and hearing-impaired children who were denied admittance to schools and who face with discrimination. CSOs learned about the national and international rights-seeking mechanisms both on hearing aids and rights violations and discrimination and employed these mechanisms through administrative applications.

Audiologists, doctors, and speech specialists from the Association of Hearing and Speech Scientists – a platform member – from Ankara, examined and provided guidance to 14 children from nearby towns and villages. These activities were very important for the disabled in the province where there were no speech disorder specialists or audiologists. Thus, we have not only touched CSOs but also made a difference in the lives of the hearing-impaired and deaf children and their families. Our project is very valuable with respect to this feature as well, inasmuch as it is the first and only study to strengthen the deaf and hearing-impaired CSOs. Our goal was to expand the platform and empower CSOs in every aspect. We are very happy that we made our dreams come true."

We designed our project for CSOs working with refugees in partnership with IKGV because we know the value and difficulties of the work of these CSOs. They heal the "other", advocate and negotiate for the "other", they deal with their health, shelter, and other needs. We have been working together since April 1st, 2019 to heal and support them. The exhaustion rate of employees in this field is very high. While it is very difficult being "the other", it is also very difficult to testify to the tough process encountered on behalf of the "other". The trauma of witnessing their struggles takes a heavy toll on employees and it requires serious self-sacrifice. It is a serious effort to try to give life and hope to people who have lost their place, homeland, self, possessions, respect, dignity, hope, and sometimes their honour; it is a work full of pain, sadness, and despair. "Someone thought of us too," said one of our colleagues at one of the project events. We have always asked why our colleagues working in this field despite witnessing all kinds of trauma, choose to do so day after day. When they explain why they are in this profession, the motivation to change something is evident. Even when the effort on behalf of the "other" gives good and beautiful results, those who feel the pains of the process will become more human; then really someone should think of "YOU".

We aimed to bring this issue to the attention of policymakers and those working on or in youth-related fields by presenting a quantitative-based case study about youth not in education or employment. Additionally, we focused on highlighting these models and building their capacities in the field of advocacy by drawing attention to the working models of CSOs working on youth empowerment. With this perspective, we organized the "Impact Assessment, Research Methods and Advocacy Training for Youth CSOs" for the personnel of relevant CSOs from various provinces in Türkiye. We prepared the "Manual for Applied" Quantitative and Qualitative Research Methods Used in Development Projects" that can be useful for CSOs and policymakers working not only on youth issues but also on all issues regarding development. We have prepared a comprehensive research report that includes an extensive literature review, analyses of various micro-datasets, and CSO models and policies that address youth issues. We organized webinars with policymakers and academics to disseminate the research results. We hope that we raised awareness on the situation of young people who are not in education or employment, improved the capacity of CSOs in research methods, and thus contributed to the empowerment of young people in Türkiye through all these activities.

Fathers stated that they have started to take more responsibility for their children's nutrition, care, and education, as well as spending more quality time with their children. 

The networks established during these events were useful for students, teachers, and educational law enforcement agents to obtain information about each other. We talked to students, teachers, and directors and prepared an "impact analysis report" after investigating the impact the project had. We visited the schools for the visually impaired in 6 provinces together with our visually impaired participants who have been successful in different fields. We prepared a book describing the lives of our participants and a film introducing the project. We strengthened our institutional capacity with the training we provided. Thanks to our project, our childhood friend, Cin Ali, who never grows up, is now in the world of the visually impaired.

At the end of the training and mentoring processes, the municipalities designed their own communication campaigns on bicycle transportation. All three municipalities have stated at every opportunity how valuable and productive it was to work with different units of the municipality (technical, communication, operational) and with CSOs. At the end of the project, we published a report containing the experiences, communication campaigns, and results obtained by each municipality during this period. We hope that this report will be a roadmap for other municipalities in Türkiye that want to turn to bicycle transportation.

The association strategy, communication strategies and related presentations, and the input from experts from our partner, IFOAM, excited our participating association members. They had the opportunity to observe innovative and international practices.

Highlights from the Project

- Workshops were held in İstanbul and Antalya with the participation of food banks, CSO representatives, retail and producer corporate companies, HORECAs (hotel, restaurant, catering), public institutions, local administrations, and government representatives to create a "common sense and action" strategy to prevent food waste.
- The first "Advocacy Guide" to guide CSOs to build a strong advocacy for the reduction and prevention of food waste was prepared.
- The "Legislative Proposal Report" on food waste management and food donation was compiled.
- The "Industrial Symbiosis Feasibility Report" was prepared to guide the mapping of food waste, recycling of the waste, and the operation of circular economy processes in Türkiye.
- At the final meeting, all reports and guides created during the project were shared with the public.
- A national network that started with the manifesto of "Save Your Food" and that brought together all its stakeholders, was created.



A strong public-CSO-private sector dialogue was exemplified during the implementation process of our project, which brought up food waste to the agenda in Türkiye, brought together all stakeholders in food, and contributed to the creation of a strong cooperation and dialogue environment among the public-civil society-private sector components. Through this dialoque environment, it was possible to create data-based project outputs that were developed with common sense. Many practices, such as ensuring the participation of civil society in decision-making mechanisms and increasing advocacy capacity, including policy proposals in public agendas, were realized through the exemplary studies directly followed in the Save Your Food Project. In the project, three main publications and reports were created, which is a first in Türkiye. The first of these, the "Advocacy Guide", will quide civil society organizations to create strong advocacy for the reduction and prevention of food waste. The "Legislative Proposals Report", in which national legislation was developed with proposals to reduce food waste and encourage food donation, has the characteristics of being the first report and legislation guide in Türkiye. Last, the "Industrial Symbiosis Feasibility Report", a publication that will map food waste in Türkiye and form the basis for the operation of waste recovery and circular economy processes, was created.

Highlights from the Project

- · Meetings were held with Global Food Banking Network experts.
- A guide containing food bank standards, procedures, and principles was published.
- A guide for food bank training and consultancy processes was published.
- A guide on control mechanisms and processes of food banks was published.
- Meetings were held with local administrations and local CSOs in 24 provinces of Türkiye to promote food banking and to lead the way in opening new food banks.
- Meetings for "Food Donation" were held with producers, wholesalers, and retailers.
- The digital "Support Cloud Platform" and application, where the donation system is managed, was developed.
- Training and consultancy programmes were offered to municipalities and CSOs that will open food banks.
- Inspections were carried out in the 3 newly opened food banks.



We aimed to strengthen the capacity of food banks to take a more active role in combating poverty and waste through this project. To achieve this goal, we created guidelines on standards and procedures and provided training and consultancy programs to enhance their administrative and financial, communication and advocacy, and transparency and accountability skills. We held meetings in 24 provinces and provided consultancy services that led to the opening of 12 new food banks. Thanks to these newly established food banks, 12,000 people in Adana, where we conducted our pilot study, and 100,400 people throughout Türkiye were able to obtain food and hygiene items to meet their basic needs. We believe that our project has laid the foundation for a sustainable and impactful initiative that will continue to grow and benefit large communities.
