# Communication (2000) 265 Promoting sustainable development in the EU non-energy extractive industry

- Sets broad policy lines for promoting SD by reconciling the need for more secure and less polluting extractive activities while maintaining the competitiveness of the industry
- Evaluation of COM (2000)265 to be completed by early April
