□ National Roaming: Separate By-law published in March 2002

Interconnection Rates

- ☐ As defined in By-law on Access and Interconnection
 - ☐ Forward looking long-run incremental cost
 - Cost of efficient service provision
- ☐ EU funded Technical Assistance Project on Access Regime

Review of the Agreements

- □ Follow-up for non-discrimination principle
- → Probable anti-competitive behaviours in the initial phase of iberalisation
- ☐ Extensive examination of the agreements signed by operators having SMP

Reference Interconnection Offers (RIOs)

- □ Türk Telekom RIO approved in 2004 and amended in 2005
- □Turkcell RIO approved in 2005
- ☐ 2006 Review for amending the RIOs in progress
- ☐ Vodafone and Avea RIOs under review

Communiqué on Local Loop Unbundling

□ Published in July 2004 and enacted by July 2005
 □ Scope
 □ Definition of unbundling obligation
 □ Pricing rules
 □ Dispute resolution procedure
 □ Reference unbundling offer (RUO)
 □ RUO submitted by Türk Telekom

☐ Public consultation and review of Türk Telekom completed

☐ To be published after review and approval of TA





Communiqué on Facility Sharing and Co-location

- ☐ Enacted in December 2003
- ☐ Scope
 - ☐ Definition of the obligation of facility sharing and co-location
 - Demand and supply procedures
 - □ Pricing rules
- ☐ Implemented in the RIO and the draft RUO





Accounting Separation and Cost Accounting-I

- □ Obligation for both fixed and mobile network operators having SMP in related markets
- ☐ Requirement of having separate accounts for the business units defined in terms of revenues, costs and capital employed
- ☐ Details of the accounts and reporting formats specified in the "Principles and Procedures"





Accounting Separation and Cost Accounting-II

- □ Accounting separation obligation for the first time →two-year transition period
- ☐ Implementation in the transition period carried out by the study groups composed of both TA's and operators' representatives
- ☐ TA may audit the operators' accounts or request independent auditors' verifications from the operators

Leased Lines

- ☐ Cost orientation obligation for wholesale leased line tariffs
- ☐ The Board examines the tariff proposals under the principle of cost of efficient service provision
 - Benchmarking can also be used

- ☐ Revision of By-law on Access and Interconnection
 - ☐ Remedies based on market analyses
 - ☐ Differentiation of the obligations among the markets and among the operators having SMP
