




Overview of Current Situation (1)

Broadband Infrastructure (March, 2006)

Technology	Number of subscribers	Penetration (%)
ADSL	1,841,354	2.5
Cable modem	30,273	0.04







Overview of Current Situation (2)

Liberalization:

- > Electronic communications sector liberalized in 2004
- National regulations mostly consistent with new regulatory framework


Initiatives regarding broadband use and PC ownership:

- Broadband connections to schools
- > IT classes in schools
 - √ Basic Education Project Phase II
 - √ 100% Support to Education Campaign





Broadband Development Initiatives



Main Principle: Minimum intervention to functioning of the market

13 July 2006 The Republic of TURKEY





2010 Targets

	Current	2010
Broadband subscriber penetration (%)	2	12.5
Enterprises with broadband access (%)	20	70
Cost of broadband to end user/income per capita (%)	5.4	2
Broadband coverage (%)	75	95





Envisaged Activities (1)

Supply Side Initiatives:

Authorizations regarding new broadband infrastructure and services

- > 3G Mobile Services
- ➤ Wireless Broadband Services (LMDS, Wi-Max, etc.)
- > Power Line Communications

Demand Side Initiatives:

Financial Incentives

- > Reducing "Special Communication Tax" for internet services
 - **Current rates:**
 - √ 15% for fixed services
 - √ 25% for mobile services.





Envisaged Activities (2)

Demand Side Initiatives:

Promoting computer and internet use

- Campaign for computer and broadband connection ownership
 - ✓ Decreasing tax burden (VAT, Special Consumption Tax)
 - ✓ PPP with financial institutions and suppliers
- Establishing "Public Internet Access Points"
 - √ 4500 PIAP's all around the country
 - ✓ Provision of basic IT education in PIAP's by qualified personnel





Envisaged Activities (3)

Demand Side Initiatives:

Promoting computer and internet use

- Opening IT classes in schools to citizens
 - ✓ At least one IT class in every high school
 - ✓ Opening IT classes to citizens at predetermined time intervals
- > IT education for students and adults
 - ✓ Updating curriculum to cover basic IT skills
 - ✓ Skill development courses for adults in IT classes
 - ✓ Provision of IT courses for conscripts
 - ✓ IT skill development for civil servants





Envisaged Activities (4)

Demand Side Initiatives:

Promoting computer and internet use

- Pilot project for ICT awareness and usage in rural areas
 - ✓ Providing hardware and internet access to entrepreneurs
 - ✓ Access to agricultural information via ICT's
- Actions regarding internet security
 - ✓ Regulations for responsibilities of service providers and internet cafes regarding on-line content
 - ✓ Security certification for e-Commerce sites
 - ✓ Regulations regarding the protection of personal data





Envisaged Activities (5)

Demand Side Initiatives:

Public sector activities

- > e-Government applications
 - √ e-Government gateway
 - Integrated service provision via a single portal
 - Common services (ID management, e-Payment)
 - Accessible through mobile platforms
 - ✓ Secure government network
 - √ e-Health projects
 - Access to health information for doctors
 - Information exchange among health institutions
 - Telemedicine applications





Envisaged Activities (6)

Demand Side Initiatives:

Public sector activities

- > e-Procurement
- Transportation portal
 - ✓ On-line provision of transport information (routes, time, costs, traffic density, accidents, etc.)
 - ✓ On-line reservation and purchase





Envisaged Activities (7)

Demand Side Initiatives:

Developing on-line content

- Digitalisation and on-line provision of printed and audio-visual content
 - √ Tourism portal
 - Information on touristic and historical places
 - Information on tourism facilities and on-line reservation
 - Information exchange among tourism agencies
 - √ Education portal
 - Electronic provision of curriculum content
 - Access to administrative information for students





Envisaged Activities (8)

Demand Side Initiatives:

Developing on-line content

- Cultural Portal
 - ✓ Enhancements with audio-visual content of TRT
- > Portal for academic theses
- Integrated library system
 - ✓ Searching and reservation of printed-electronic material
 - ✓ Electronic provision of mostly demanded material
- Legal regulations regarding DRM





Envisaged Activities (9)

Demand Side Initiatives:

Initiatives for SME's

- > Broadband access for SME's
 - ✓ Provision of computers and broadband connections, 50% subsidised by the government
 - ✓ Web hosting
 - ✓ Covering 150,000 SME's

Connecting Public Administrations

- Demand aggregation
 - ✓ Developing infrastructure in remote areas
