LEGAL FRAMEWORK

- ☐ TUBITAK Law No.278 (1963)
- Commissioning of the Prime Minister on the 25th of November, 1999, employing UEKAE with the task of technically supporting all government and private sectors in the fields of network and information security.
- Circular issued by the Prime Minister on the 3rd of September 2004, tasked to UEKAE with the establishing and operating of "Public Certification Authority" for supplying digital certificates to the Government organizations for use in electronic signature applications.






MAIN OBJECTIVES and TASKS
