Eligibility criteria

Aid per ha is granted to farmers producing cotton

Conditions:

- Agricultural land authorised by the Member State for cotton production
- Use of authorised varieties
- The crop must be maintained at least till the opening of the capsules



Authorisation of land

Objective criteria for authorisation of agricultural land for cotton production

- Agricultural economy of the region for which cotton production is important
- Agricultural condition of the land
- Management of irrigation water
- Environmentally sensitive rotation and farming techniques



Other conditions of eligibility

- Complete sowing of the land (plant density)
- Agronomic practices specific rules
 - > fertilizers
 - *≻***irrigation**
 - > pesticides



Base areas and amounts of aid

National Base Areas:

- Greece 370 000 ha
- Spain 70 000 ha
- Portugal 360 ha

Amount of aid per eligible hectare:

- Greece 594 €
- Spain -1039 €
- Portugal 556 €
- Proportional reduction in case of overrun of the National Base Area



Approval of the Inter-Branch Organizations (IBO)

- An area of at least 10 000 ha + at least one ginning plant
- Inter-branch organization carries out well identified actions:
 - >to increase the value of the produced unginned cotton
 - ➤ to improve the quality of the unginned cotton according to the needs of the ginner
 - >to use environmentally sensitive methods of production
- Inter-iranch organization adopts internal procedures (conditions of conformity and contributions) in particular:
 - ➤ the conditions of and contributions, according to the national and Community rules
 - > the scale of distribution of aid by land plot category determined according to the quality of the unginned cotton to be provided



Commitments of the producers

- Voluntary adhesion but:
- Membership is limited to only <u>one</u> inter-branch organization
- Producer must deliver the cotton to a ginner belonging to the inter-branch organization



Differentiation of aid

- Maximum ½ of the total amount of aid is differentiated according to a scale
- Land plot category established on the basis of:
 - ➤ Fibre length
 - >Humidity content
 - ➤ Average impurity rate
- Classification of parcels within the scale by plot category



Communications to the producers and the Commission

- Members State should communicate to the cotton producing farmers (before 31 January):
 - > Authorised varieties
 - > Criteria of land authorisation
 - > Plant density
 - > Agronomical practices
- Members State should communicate to the Commission:

Before 30 April – names and main characteristics of the approved IBO

Before 15 September – sowed surfaces with aid applications

Before 31 July – final dates concerning the sowed surfaces having received the crop specific payment for cotton
