Overview

Trade in ECSC Products

Trade between Turkey and the EU member states on ECSC products is being managed by Turkey-ECSC Free Trade Agreement, which puts this area out of the scope of the Customs Union.

However, in Turkey's FTAs with third countries, these products are treated the same as other industrial products.





Overview (CONT'D)

Iron and Steel Industry (2005)

- 21 million tons crude steel production,
- 10.5 million tons steel products exports,
- 9.3 million tons steel products imports,
- 11th largest producer in the world steel output.


